New Business

Mary Meloy led a discussion about the role and acknowledgement of public works personnel as first responders on 9/11. She pointed out that there is a lack of recognition about this topic at the national level and she'd like to figure out a way to get the same honor and recognition as the police and fire departments. There is a book about this by William Langeweische which provides a unique insight to the events of 9/11 and the unsung heroes that did not show up on the nightly news. Mary is going to do some research to find out if there is more information about this topic that we can use at the local level.

Todd Watkins requested \$32 to be paid to Nanci Snyder to reimburse her for two students to attend the November APWA luncheon in Portland.

Motion to approve the reimbursement made by Paul Shirey and then seconded by Gordon Munro with a unanimous approval.

This request morphed into a discussion about the possibility of providing monthly scholarships to the luncheons so that we can get more students to attend. This topic needed more time to work out the details so it will be on a future agenda.

Additional discussion about the annual foundation scholarship occurred and it was mentioned that it might be worthwhile to have scholarship recipients do a little more when it comes to what we expect from them. However, this would need to be coordinated with the foundation since it is technically their scholarship program.

A brief discussion also occurred regarding the First Timer's program and the relationship between the First Timers and their mentors. We need to be making sure we encourage the mentors to stay in touch with their First Timers in order to keep those relationships going as another way to build our membership base.
