statewide earthquake exercise, Quakex03, scheduled for April 2003. All government entities, private industry, and
volunteer organizations are welcome to
take part. The scenario features a major
earthquake in the Cascadia subduction
zone, with resultant tsunami waves.

The exercise, planned by Oregon Emergency Management, will have two components. The response phase (the first two days after the earthquake) will take place April 2-3, 2003. The recovery phase (seven to eight days after the earthquake) will take place April 8-9.

Merseth Honored with Bowes Award

The Oregon Chapter of APWA conferred it highest honor, the William A. Bowes Service Award, on Gordon L. Merseth, P.E., principal of Crane and Merseth, at the Fall 2002 Chapter Conference in Pendleton.

William Bowes was a Portland city commissioner (of public works) who was

instrumental in establishing the Oregon Chapter of APWA in 1964. The Bowes Award was established in 1978 to honor a chapter member for "Distinguished Service Given To The Chapter and its Members." The Bowes award is the highest honor the chapter can bestow on a member.

Joint Standards Classes Under Way

ODOT and APWA have teamed up to present an introductory class on use of the 2002 ODOT/APWA Joint Standard Specifications and Drawings. The class explains basic use of the specifications and drawings, major changes, and highlights issues first-time users should be aware of to help them be successful applying the new specifications. The new Joint Standards are the classroom textbooks, and attendees are taken on a guided tour through the Standards to give them first-hand experience using the Standards. Some of the material taught in the class is from the Users Guide, and copies of the guide are sent home with each person who attends.

Sessions of the class were held in Wilsonville, Bend and Eugene in October and November, with a total of 255 attendees. Additional classes are scheduled in Eugene and Hillsboro in December, and in Medford in January. Instructors are Dale Deatherage, ODOT Specifications Engineer, and Paul Klope, City of Eugene.

The interest in learning about the new Joint Standards has far exceeded expectations. During planning for the training, the original arrangements were for two trainings, with an estimate of 50 people in Wilsonville and 30 people in Bend, and no future sessions scheduled. The Wilsonville class grew to 165 (with a waiting list) and had to be moved to the Holiday Inn Conference Center, and the Bend class grew to 45. Some of the people not able to get into the first two sessions stepped up and arranged for the training to be repeated in Eugene, Hillsboro and Medford. The December classes in Eugene and Hillsboro will host 150 people and are full. Further classes are not scheduled, but may be if there is sufficient interest.

ODOT Begins Converting Back to English Units

The Oregon Department of Transportation has begun converting back to the English Unit of Measurement for its contract plans. This decision follows extensive discussions with the Association of General Contractors (AGC) and the local American Public Works Association (APWA) chapter. This conversion would make the state consistent with Oregon cities and counties by using a single measurement system for road construction projects.

In 1991, Congress and the Federal Highway Administration mandated that all federal-aid construction projects be in metric units by September 30, 1996. ODOT began metric conversion in 1993 and started to contract metric projects in 1996. Since then, Congress has removed the requirement that contract plans be in metric units. After the removal of the metric requirement, most states have reverted back to English, with Oregon being one of eight states that still uses metric units. A total of 35 states use English measurements and an additional seven states use a dual system. In addition, most cities and counties in Oregon continued to use English measurements.

The original intent of the federal mandate was to have all state DOTs using metric measurements and even

though ODOT believes the metric system to be the most efficient system of measurement, it is more important to be in alignment with other state DOTs and our local government partners.

Below are some general timelines for ODOT's conversion to English units:

- January 2003 Begin contracting local projects and state consultant projects in English units, if those projects do not depend on ODOT standard drawings for their development. Local projects that depend on ODOT standard drawings may need to wait until as late as June for ODOT's standard drawings to be converted into English units.
- March 2003 Begin gathering survey information in English units
- July 2003 Begin development of state projects in English units
- April 2004 Begin contracting state projects in English units
- October 2005 Most projects contracted in English units

This schedule doesn't dictate that projects be immediately converted from metric to English. Each project is unique and will be evaluated individually to determine whether to convert to English units or complete the project in metric units. Project schedules will not be delayed for unit conversion.

Local or consultant projects will need to be evaluated to determine if the necessary English measurement contract support items, such as standard drawings, are available (many support items will not be completely converted until July 2003). Most likely the first state English unit projects contracted will be simple preservation projects followed by more detailed modernization projects.

Allison Hamilton, (503) 986-3558, is heading up ODOT's English conversion process and is forming an English Conversion Committee.

Drawing Revisions Available on Web

Revisions to the ODOT-APWA
Standard Drawings are made frequently.
If you own the hard copy version of the
Standard Drawings, ODOT will send out
notices of revisions when they are made,
with a copy of the revised drawings, or
information about where to obtain a
copy of the revised drawings. APWA will
revise the AutoCAD version of the english
drawings as soon as possible after
receiving the notice of revision from
ODOT.

When APWA has completed the revision to the AutoCAD version, a copy of the revised drawing file will be posted on a special site (called an ftp site). Your internet browser can be used to navigate to the ftp site where you can download a copy of the revised drawings files.

The revised drawing files will remain on the ftp site for 60 days. If you need an electronic copy of a revised drawing that has already been removed from the ftp site, contact the APWA office at 541-926-0044.

Infrastructure within the public right-of-way is rightfully intended to serve the needs of and provide a benefit to entire communities. At the same time, communities have the responsibility to balance their needs and requirements against available resources as part of their overall service delivery missions."

That's how National APWA President Martin Manning starts his letter of recommendations to the U.S. Access Board on the issue of draft guidelines for accessible public rights-of-way. This issue affects anyone who designs, constructs, or maintains public facilities in the right-of-way.
